As a manager, coach or assistant coach in the Shawnee County Amateur Baseball Association and Shawnee County Parks and Recreation league, I will abide by the rules and follow the recommendations and suggestions of the League.

I agree to set a good example for my team players, other team coaches and team supporters. I will do my best to teach better baseball and teach good sportsmanship to everyone involved. I will encourage my players, other coaches and team supporters to extend a hand of friendship to all opponents and their supporters.

Code of Conduct

As a manager, coach or assistant coach in the Shawnee County Amateur Baseball Association and Shawnee County Parks and Recreation Leagues, my responsibilities will include any unsportsmanlike behavior from any manager, coach, player, parent/guardian, or spectator affiliated with my team. Unsportsmanlike behavior includes, but is not limited to:

- Verbal and/or physical abuse of an umpire, any player, any manager/coach, parents/guardians, spectators, or league officials;
- Consumption of alcoholic beverages or controlled substances while in the complex or at practice;
- Being under the influence of alcoholic beverages or controlled substances during the game or at practice;
- Being in possession of a firearm or weapon, except for law enforcement personnel;
- Obscenities, racial slurs, or gestures that are inappropriate or demeaning;
- Inciting or encouraging abusive and dangerous actions from players or spectators;
- Baiting, ridiculing and or threatening an umpire, any player, any manager/coach, parents/guardians, spectators, or league officials
- Use of profane and/or derogatory language; any body language deemed inappropriate.

I further understand that when an incident occurs, the game will be stopped and the offending individual(s) will be asked to leave complex. The game will not continue until the individual(s) comply with this request. If the individual(s) refuse to leave, the umpire will immediately suspend the game and notify a league official and be dealt with by proper authorities. All incidents will be reported to SCABA and SCPR, who will investigate all actions reported, and follow up with all parties.

My main concern will be the best interest of my players and the Association. Failure to cooperate with the Association in correcting any problems or disagreements may result in the suspension and/or termination of my opportunity to be a manager or coach in SCABA and/or any SCPR leagues.
